Dear Sir

I did not say anything to you on the subject of my being a Candidate when you were here last as I had understood from Mr McNamee your views on the subject. and feel very grateful to you for favoring me at this time. When I not situated as I am with regards to pecuniary matters. I would not on any account have been a Candidate for the last few years for any office. A report is now in circulation that I am receiving a very heavy salary from a few offices that I hold. This is the only year that all the offices I hold will amount to over \$500. for the last few years it has been agreed that the appointment of Sec & Treas. of the Erie Cemetery this last winter is what brings it up to the \$523.00.

The Motany Public is worth nothing or next
to nothing not amounting to over \$20.00 a year
I have not made out to exceed a dozen deeds
since I came to the Court House - There is a
Strong feeling amongst the Shanghaies to desert
me. they cannot forgive me for volunteering as
a police man when ~~three~~ of three appointed
by the Mayor refused to serve. or for vol
unteering to stand guard the night that
Gov. Bigler arrived when in the midst of
the great excitement almost all the Police
force left the Rail Road Depot

They have persecuted me in every way that
they could but of this I will say no more -
If you can do any thing for me which
I know you will. It will be conferring a
very great favor on me.
